### Day of show Entries:

If we do not reach our limit, we may accept day of trial entries. The cost will be \$15 per run for any entries sent after the closing date.

### Refunds:

There shall be no refunds for entries withdrawn in the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal. A full refund\* will be given for any requests for withdrawals received prior to the closing date. Refunds requested after the closing date will be given only for a dog or handler which suffers an injury and/or illness or bitches that come into season. **Requests for refunds must be received in writing by 8PM FRIDAY September 6<sup>th</sup>. No refunds will be given after that time.** Please include documentation from your veterinarian or physician verifying the illness or injury. An administration fee of \$3 per run will be charged for entries cancelled after the closing date. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, snow, acts of God, public emergency, an act of a public enemy, or any other cause beyond our control.

\*Any PayPal or Venmo transaction fees incurred by NAE will not be refunded in the event of a withdrawal.

**Dogs which require measuring:** Dogs in the Proficient Category, Novice, Open or Elite jumping 4", 8", 12" or 16"  
\*PLEASE NOTE: ALL DOGS will be required to have a permanent height card (even if they are running in Skilled) starting January 1, 2025. There will be more than one judge available for measuring at this trial.

**JUMP HEIGHTS:**

There are four jump heights for the Veterans and Junior Handler divisions: 4", 8", 12", and 16".

## Brief Summary of Rules:

Please refer to [www.nadac.com](http://www.nadac.com) for a full explanation of all NADAC rules and up to date information.

- Please note that NADAC trials should provide a safe and fun environment for both exhibitors and their dogs.
- Aggressive dogs will not be tolerated and will be excused from the trial.
- The show committee has the right to refuse any entry. Anyone not currently in good standing with NADAC will not be allowed to enter this trial.
- Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations, and agree to abide by all rules in effect at the time of this trial.
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Checks not honored by the bank do not constitute a valid entry fee. There will be a \$25.00 service charge for bank returned checks.
- Dog must be registered and have a valid registration number before entries will be accepted. <https://www.nadac.com/register-your-dog/>
- A copy of the current Exhibitors Handbook may be downloaded free from the NADAC web site: [www.nadac.com](http://www.nadac.com)
- Bitches in heat, lame, or blind dogs are ineligible for entry, as is any dog with a deformity which may cause a judge to not be able to reasonably assess the dog's ability to function and perform agility obstacles safely, and in a manner that is in the best interest, health and welfare of the dog.
- No food, clickers, or other aids or devices shall be permitted on the course or within 10 feet of the ring. Food or a small non-audible toy can be in a secure container (ziplock bag is acceptable) in your pocket during your run but you cannot indicate to the dog it is there. All handlers may bring a non-audible toy into the ring for training purposes. They cannot earn a Qualifying score and must declare to the judge they are training before they commence their run. Please read the Exhibitor's Handbook for more information about toys and training in the ring.
- The sponsoring clubs will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result be accident or other cause. It is distinctly understood that every dog at this event is in the care and control of his owner or handler during the entire time the dog is on the show premises.

## **AGREEMENT**

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

- 1.1. As used here "NADAC" means the North American Dog Agility Council, LLC., its members, officers, directors, employees, show chairs, show committees and agents.
- 1.2. Exhibitor/owner agree to abide by the rules and regulations of NADAC and any other rules and regulations appearing in the premium for this event.
- 1.3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
- 1.4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the surface, restrooms, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.
- 1.5. Exhibitor/owner releases NADAC (including its respective officers, directors, employees, and members), Northeast Agility Enthusiasts (NAE) (including its officers, directors, members, and event organizing committee), and Kampfires (including its officers, agents, and employees) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assumes sole responsibility for and agrees to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury or death may be caused and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

## Pricing Info:

For all entries sent on or before the closing date, take the total number of runs all dogs from the same household are entering at this trial and calculate entry fees accordingly.

**SPECIAL DEAL for \*NEW TO NADAC\* EXHIBITORS** - If this is your first NADAC trial you can enter as many classes as you want for \$25 per dog per day (pre-entry only; no other discounts may be applied). Kampfires visitor fees still required in addition to per dog fee.

**DISCOUNT for NEW or LONG LOST NAE EXHIBITORS** – If you are new to NAE or haven't attended one of our trials in the last 5 years we are offering you two free runs. A minimum entry of four runs total is required, pre-entry only. Give us a chance to win you back!

**JUNIOR HANDLERS** - (age 17 and under) \$10/run.

**DAY OF SHOW/AFTER CLOSING** - The cost for any entries sent after the closing date IF ACCEPTED will be \$15/run (no discounts or coupons may be applied). We will not know until after the closing date if we are able to accommodate any day of show entries.

**VISITOR ENTRANCE FEES** - Kampfires charges us a \$5/PERSON/DAY entrance fee for all visitors. All campground visitors (entered exhibitors and all guests) coming for the agility trial must be registered with NAE, EVEN IF THEY ARE NOT RUNNING A DOG. The visitor entrance fee is now listed as a separate line item under Standard Fees on the entry form. Please register all visitors (INCLUDING YOURSELF) with NAE, note any extra days you will be present at the campground, and include the visitor fees along with your entry fees for each day you and any guests traveling with you will be present on the premises of the trial site. This includes if you come for setup on the day before you are trialing. **We will happily cover the entrance fee on Friday for anyone coming to help us set up for the trial. \*No visitor fees are required for anyone who has paid for a campsite so please let us know if you will be camping on-site.\*** We appreciate your understanding and cooperation.

**From the South:** Take I-91 North to Exit 3 in Vermont. Off the exit ramp, go part of the way around the round-about (rotary), and go North (right) onto Rte 5. Follow Route 5 north. At 2.5 miles, Kampfires entrance is on the right.

**From the North:** Take I-91 South to Exit 4. At the end of the exit ramp, turn left onto Rte 5 South. At 3.5 miles, Kampfires entrance is on the left.

**From the East:** Take Rte 9 West toward Vermont. Shortly after entering Vermont (not even 1/2 mile), enter the round-about (rotary), and make your first right to go north onto Rte 5. Follow Route 5 north for 2.5 miles. Kampfires entrance is on the right.

**From the West:** Take Rte 9 East toward Brattleboro. At I-91, cross bridge over the highway and turn left onto the entrance ramp for I-91 North. Exit at the next (Exit 3). Off the exit ramp, go part of the way around the round-about (rotary), and go North (right) onto Rte 5. Follow Route 5 north. At 2.5 miles, Kampfires entrance is on the right.

Anyone wishing to camp on site must make a reservation directly with the campground. Kampfires has blocked off the trial dates within their reservation manager to ensure that NAE has first dibs on the F-Section camping sites for our events. This is the camping area located by the recreation field where the agility trial is held. Because the F-section sites are blocked they will not show available on the online booking system, so please give them a call or send an email to secure your reservation. Camping sites in other areas of the campground can be booked online directly from their website. The earlier you book the more you will save. The block of sites will be held up to 30 days prior to the event, then will be released to the general public. Please note, when placing your reservation a 50% deposit is required. ## **DOUBLE RUN FORMAT**

Ever wish that you could have a do-over, or try out different handling on the same course? Now you can have your chance. Any classes offered twice in the same day will run the same course twice with no official walk-thru in between. We are using this format in order to drastically help ease the burden of course building 8 classes per day and 4 levels for each class on our chief course builder and our wonderful volunteers.

We will be offering a small break between round 1 and round 2 **for any classes with less than 10 runs** in order to give everyone a breather since our trials can be on the small side and we don't want anyone to feel rushed.
